Channel partner may avail itself of the migration price for Eligible Licenses when an Eligible Customer licenses Creative Cloud for teams commercial annual plan membership (complete, complete + Adobe Stock, or single app), or government annual plan membership (complete or single app), and enrolls in the Adobe Value Incentive Plan (VIP).

Eligible Customers may contact an authorized channel partner for channel partner's migration price. Adobe does not set the pricing that channel partner charges customer and Adobe cannot guarantee any particular discount or price to customer. Channel partner will determine actual license fees for Eligible Customers. Migration pricing is valid for customer's initial VIP license term after migration. If the initial membership term is 13 months or less, then migration pricing is also valid for the first and second renewal of Eligible Licenses. Migration pricing may not be applied retroactively.
