The Case Review App, which e-discovery administrators can access from either the Mimecast Administrative Console or from the Mimecast web site, provides a set of tools for selecting relevant subsets of archive data for conducting e-discovery, compliance, and other investigative searches, and for sharing them quickly and securely with reviewers involved in the case. The Case Review App offers reviewers an intuitive workspace for marking messages for relevance, privilege, and other criteria.

Hidden costs of first-pass reviews

While email first-pass review is just one of many components of ECA, it is vital. A single case may involve vast numbers of messages, and searching and qualifying this semi-structured data poses unique challenges. Tight deadlines and competing priorities often lead administrators to cast a wide net in their first-pass reviews, using a bare minimum of key words and other criteria. The massive files that result from this usually contain a great deal of redundant, obsolete, or trivial ("ROT") data.

In-house teams then export these "dirty" email files to outside counsel or e-discovery service providers for further vetting and categorization, the fees for which can exceed \$300 per hour. This puts organizations in the ironic position of paying premium rates to perform relatively menial cleanup work.


Robust message review
